Inclusion of Viable Agricultural Land in a Certified Agricultural District
Before the District's Established Review Period

By Legislator: _____

Whereas, New York State Agriculture and Markets Law Article 25AA, Section 303-b required that Counties establish an annual thirty day period within which to accept requests by landowners to have viable agricultural land included in a certified Agricultural District and;

Whereas, the Jefferson County Board of Legislators passed Resolution No. 98 of 2004, Establishing an Annual Thirty Day Period from June 1 to June 30 for Landowners to Submit Proposals to Include Viable Agricultural Land within an Existing Agricultural District Before the District's Established Review Period; and

Whereas, In accordance with Section 303-b of Article 25AA of the New York State Agriculture and Markets Law the requests for inclusion were referred to the Agriculture and Farmland Protection Board for review and recommendation; and

Whereas, the report and recommendation of the Agriculture and Farmland Protection Board has been submitted to this Board; and

Whereas, a public hearing was held on September 29, 2004 to receive public comments; and

Whereas, the Jefferson County Board of Legislators has reviewed the requests for inclusion, the recommendation of the Jefferson County Agricultural and Farmland Protection Board, and the Public Hearing record concerning the Inclusion of Viable Agricultural Land in a Certified Agricultural District Before the District's Established Review Period.

Now, Therefore, Be It Resolved, That, pursuant to Agriculture and Markets Law Article 25 AA, Section 303-b, the Jefferson County Board of Legislators does hereby approve the inclusion of 22 parcels encompassing 2,047 acres, list attached, to existing Agricultural Districts.
